

Terms of Use Policy

Thank you for considering It Takes A Village Special Needs Parent Coaching LLC. Our mission is to provide personalized coaching services to parents of children with special needs. Our Terms of Use policy is designed to protect both our coaches and clients and to ensure a positive coaching experience for all. The following Terms of Use ("Terms") describe your rights and responsibilities when using our services.

1. Acceptance of Terms

By accessing or using our services, you agree to be bound by these Terms. If you do not agree to these Terms, please do no use our services.

2. Description of Services

Our coaching services are designed to provide guidance, support, and resources to parents of children with special needs. Our coaches will work with clients on an individualized basis to address their unique needs and challenges. Coaching sessions may take place in person, over the phone or online.

3. Use of Services

You must be 18 years of age or older to use our services. You agree to use our services only for lawful purposes and in accordance with these Terms.

4. Confidentiality

We take client confidentiality seriously and adhere to all state and federal privacy laws. All information shared during coaching sessions will be kept confidential, except as required by law.

5. Coaching Programs

It Takes a Village Special Needs Parent Coaching LLC offers two distinct coaching programs:

The P.E.A.C.E. Program for Mitigating Caregiver Burnout is for parents who need assistance with managing the day to day mental, physical, spiritual and emotional stress of raising a child with special needs. This is a three month program and the cost is \$1,497.00. Payment can be made in full at the time of purchase or monthly installments of \$499 can be arranged. The first monthly installment will be due upon purchase and the remaining installments will be due on the first day of each subsequent month.

The Special Education Advocacy and I.E.P. Support program is for parents who need assistance navigating the complex Special Education system. Advocacy services require a \$600 retainer due at the time of purchase, as well as a fee of \$100 per hour for additional hours incurred.

6. Payment

Payment for coaching services is due at the time of service. We accept payment by credit card or Venmo. If payment is not received within 30 days, a late fee of 5% of the outstanding balance will be assessed.

7. Cancellation and Rescheduling

We understand that sometimes schedules change. If you need to cancel or reschedule a coaching session, please provide at least 24 hours notice. If you do not provide notice, or cancel/reschedule within 24 hours of the scheduled session, you will be charged for the full session.

8. Code of Conduct

We expect all clients to conduct themselves in a professional and respectful manner during coaching sessions. We reserve the right to terminate coaching services if a client engages in behavior that is disrespectful or abusive.

9. Disclaimer of Warranties

The Site and all related services are provided on an "as is" and "as available" basis, without warranty of any kind, either express or implied, including, but not limited to warranties of merchantability, fitness for a particular purpose, or non-infringement.
